

CRESCENT SKI COUNCIL RELEASE AND INDEMNITY AGREEMENT

READ VERY CAREFULLY BEFORE SIGNING

I, the Undersigned, in consideration of racing in the CRESCENT SKI COUNCIL RACE SERIES AND DEVELOPMENT SERIES do hereby release and agree to hold harmless and indemnify CRESCENT SKI COUNCIL, its directors, officers, volunteers, and servants of CRESCENT SKI COUNCIL from any and all such claims, actions or damages without any limitation whatsoever, whether consisting of personal injury, property damage or death, that do or may result in any way from my participation in these sporting events, whether such injuries of any kind or nature are caused by their negligence or not, assuming for myself any and all responsibility and liability for same and I will not sue.

I further agree to indemnify and hold harmless all of those above named from any damages, or costs, or expense whatsoever which they, or any of them may incur as a result of any claim brought by anyone against any of them as a result of my preparation for and/or my participation in these sporting events. I specifically agree that before any given competition takes place I will, if I so desire, inspect all areas involved in the competition fully realizing, accepting, and understanding that skiing in general, and this type in particular, is inherently risky and dangerous, as are preparation, practice or training for such events.

I know that Alpine Racing is an action sport carrying significant risk of personal injury. Racing competition is a dangerous sport. I know that there are natural and manmade obstacles or hazards, surface and environmental conditions, and risks which in combination with my actions can cause me very severe, or potentially fatal injury. I agree that I, and not the CRESCENT RACE COMMITTEE, CRESCENT SKI COUNCIL, or any officers of the CRESCENT RACE COMMITTEE or CRESCENT SKI COUNCIL, take responsibility for participating in the Racing Program and I am totally responsible for my safety while I participate in the CRESCENT SKI COUNCIL RACE SERIES AND DEVELOPMENT SERIES.

I, as a competitor, completely understand that these paragraphs constitute a covenant and a promise on my part to fully discharge all of the above-named parties from any and all liability of any kind for any injuries, loss, damage, or death which my result from my participation in these events.

This release is binding, and I so understand, not only upon myself but upon my heirs, administrators, executors and assigns, and I herewith again reaffirm my free and willing intent to execute it, acknowledging a complete understanding of its terms and conditions and the totality of its effect, and the totalness of the waiver of any rights that I would otherwise have had, had this agreement not been executed.

I hereby release and indemnify the CRESCENT RACE COMMITTEE, CRESCENT SKI COUNCIL and any of the officers of any liability in connection with my participation in the CRESCENT SKI COUNCIL RACE SERIES AND DEVELOPMENT SERIES.
