

**Trip Description: W-SSOC Ski Vacation
Salt Lake City, UT
Friday to Wednesday, January 26-31, 2018**

Eligibility: Open to Members in Good Standing of W-SSOC and (beginning August 17, 2017), Authorized Clubs of the Crescent Ski Council, from time of sign-up through last day of Trip.

Requirements to be Placed on, and Stay on, the Trip: 1) Eligibility met; 2) Trip Application current; 3) Payments current; 4) Space (air and, or, lodging) available and 5) Compatible roommate(s) available. See Trip Application for additional info.

Trip Inclusions: Basic Package includes ground transfers between SLC airport and hotel (regardless of your flight arrival/departure times), five nights lodging in double-occupancy hotel room with two Q beds, microwave, TV and refrigerator, use of indoor pool, hot tub and sauna at the Crystal Inn-Murray, Salt Lake City, UT, 4-of-14 day Super Pass/lift ticket good on public buses and lift good at any mix of Alta, Brighton, Snowbird including Tram, and Solitude (must be one day at a time at Alta and Snowbird; can be used at Solitude and Brighton on the same day), breakfast and light dinner daily, free public transportation (with the Super Pass) to ski areas, and W-SSOC Administration and parties

(1) Super Pass is good for the number of days stated within a 14-day period, starting on the first day of use. (2) For bus from Crystal Inn to Alta or Snowbird, bus stop is in front of Crystal Inn; from Crystal Inn to Solitude and Brighton, 5-minute shuttle is required from Crystal Inn to the public bus stop, and reverse on return. (3) Tips extra. Participants should plan to tip the Crystal Inn shuttle drivers, hotel housekeepers and food preparers.

(4) SLC'18 can be lengthened or shortened per Options C, D, E, F. Can be combined, back-to-back with W-SSOC Powder Mtn'18 (trip dates January 21-26, 2018), thus utilizing a single airfare for two trips. The air seats we hold are for the respective separate Option A. For back-to-back, you would need to select the Basic Package (Land Only) for both trips and get your own air.				

Guarantee of Trip Prices and Inclusions:

Except for reasons beyond W-SSOC or Agent's control, Basic Package Trip Price is guaranteed for minimum 6, up to 20, participants. Sum of Basic Package + Single Occupancy participants = maximum 20 participants. If we are able to expand the trip beyond 20 hotel spaces, and the expansion is made on or before September 21, 2017, cost will be market price; if after September 21, 2017, W-SSOC may add \$2/day up to maximum \$150 to the Basic Package Price for participants so added.

Payment Schedule. Payment required by cash, check or money order. We do not accept charge cards.

--1st \$295 due at sign-up.

--2nd IF OPTION A IS CHOSEN, \$385 due August 17, 2017.

--3rd \$400 due September 21, 2017.

--Additional payments may be made at any time in any amount.

--Balance, including any options or other price adjustments, due October 19, 2017.

W-SSOC Cancellation Policy:

Refer to the W-SSOC Salt Lake City'17 Trip Application for additional details.

- No fee for cancellation received on or before September 21, 2017.
- IF YOU CHOSE OPTION A: No fee for dropping your air and changing to Land Only provided 1) **Participant inquires in advance and receives reply from Trip Administrator;** 2) we have not dropped unneeded air and 3) we have not submitted passenger names to the airlines (i.e., issued the air e-tickets). Usually, this is done about 95 days prior to departure. Otherwise, paragraph 4. applies.
- \$25 fee for cancellation September 22 through October 19, 2017.
- \$50 fee + unrecoverable moneys (not to exceed trip cost) for cancellation after October 19, 2017. Unrecoverable moneys increase as commitments are made for you and may include any airline-related price increases.
- If your space is filled after October 19, 2017, fee is \$25 + air ticket rewrite fee (if applicable) + any direct expenses associated with filling your space (if applicable, e.g., phone, FedEx).
