

Trip Description: W-SSOC Ski Vacation, Snowmass, CO Saturday-Saturday, February 3-10, 2018

Eligibility: Open to Members in Good Standing of W-SSOC and (beginning June 1, 2017) of Authorized Clubs of the Crescent Ski Council. Membership must be current from time of sign-up through end of Trip.

Requirements to be Placed on, and Stay on, the Trip: 1) Eligibility met; 2) Trip Application current; 3) Payments current; 4) Space (air and, or, lodging) available and 5) Compatible roommate(s)/condo-mates available. See Trip Application for additional info.

Full Package #1A includes round trip air, Charlotte (CLT), NC to Aspen (ASE), CO, ground transfers, 7 nights lodging in double occupancy bedroom in 2BR/2B condo at Top of the Village Condos (ski-in/ski-out, 855 Carriage Way, Snowmass Village, CO 81615); 5-of-7 day lift ticket (includes Aspen, Aspen Highlands, Buttermilk, Snowmass); welcome party; other parties, W-SSOC Administration.

Land Only Packages #1B excludes air; otherwise includes all of the above with ground transfers, ASE-Snowmass-ASE. No refund for failure to use the included ground transfers.

- (1) "+" = Trip price will INCREASE about \$130 pp if we do not meet the "minimum 20" group size for lodging. See Note (4).
 (2) Condos vary in décor. All include full kitchen and access to on-site heated outdoor pool and hot tubs.
 (3) K + private bath in first BR; 2T (or push together to make K) in second BR with bath on the hall.
 (4) We hold 8 each 2BR/2B condos (for max 32 participants) and 26 air seats. Trip price is guaranteed with minimum 20 lodging spaces and 10 air seats. If we do not meet minimums: **LODGING.** Any price increase due to not meeting the minimum group size will be applied to the final payment. **AIR:** If minimum 10 seats is not met by October 19, 2017, air seats may be trimmed or dropped, at no penalty. If dropped, Participants will be notified and required to get their own air (= Land Only).

- (5) Single occupancy rooms at Top of the Village will be assigned to best suit the needs of the overall group. Single occupants may not request a particular bedroom at Top of the Village.

Trip Price Guarantee and Caveats (Supplements to Terms & Conditions—See Trip Application):

The cost of the included flights CLT (Charlotte)-DEN (Denver)-ASE (Aspen)-ORD (Chicago)-CLT, is guaranteed for the number of air seats held (26) and requires a minimum of 10 participants to use the air. Full Package Trip Price and Land Only Trip Price are guaranteed within the limits of available spaces (allowing for held, increased, decreased and sold) as described herein. If the trip is expanded after October 19, 2017, W-SSOC may add \$2/day, up to max. \$150, to the Full Package Price or Land Only Price **only for spaces so added.**

Payment Schedule:

- 1st: \$350 due at sign-up.
 --2nd: \$600 due July 20, 2017.
 --3rd: \$600, or Land Only balance, due September 21, 2017.
 --4th: Package Balance, including any options or price adjustments, due October 19, 2017.

W-SSOC Cancellation Policy: Refer to the W-SSOC Snowmass'18 Trip Application for full details.

- No fee for cancellation received on or before August 17, 2017.
- No fee for dropping your air and changing to Land Only provided 1) **Participant inquires in advance and receives reply from** Trip Administrator; 2) we have not dropped unneeded air and 3) we have not submitted passenger names to the airlines (i.e., issued the air e-tickets). Usually, this is done about 95 days prior to departure. Otherwise, paragraph 4., below, applies.
- \$25 fee for cancellation August 18 through October 19, 2017.
- \$50 fee + unrecoverable moneys (not to exceed trip cost) for cancellation after October 19, 2017. Unrecoverable moneys increase as commitments are made for you.
- If your space is filled after October 19, 2017, fee is \$50 + air ticket rewrite fee (if applicable) + any direct expenses associated with filling your space (if applicable, e.g., phone, FedEx, airline name-change fee).
