

# Trip Description: W-SSOC Ski Vacation Crested Butte, CO

## Saturday-Saturday, February 20-27, 2021

**Eligibility:** Open to Members in Good Standing of W-SSOC. Membership must be current from time of sign-up through end of Trip. Member of an Authorized Club of Crescent Ski Council must join W-SSOC.

**Requirements to be Placed on, and Stay on, the Trip:** 1) Eligibility met; 2) Trip Application current; 3) Payments current; 4) Space (air and, or, lodging) available and 5) Compatible roommate(s)/condo-mates available. See Trip Application for additional info.

**Land Only Packages #1A, #2A/B and #3A/B/C include** ground transfers, Gunnison airport (GUC), Colorado, to Crested Butte Mountain Resort, 7 nights lodging, all located for easy walk-in/walk-out access to slopes, in double occupancy bedroom in Hotel room at Crested Butte Grand Lodge/Emmons Suites, or 2BR/2B or 3BR/3B condo at Plaza Condos; welcome party; other parties, W-SSOC Administration. No refund for failure to use the included ground transfers. See options, below, to choose your lift ticket.

### Guarantee of Trip Price and Inclusions:

Package Trip Prices are guaranteed within the limits of available spaces (allowing for held, increased, decreased and sold) and subject to any restrictions that may arise in connection with the COVID-19 (coronavirus) pandemic, as described herein. If trip size falls below 20 participants, ground transfer prices may be adjusted accordingly. The price of other features of the Land Packages will not increase. A decision will be made before November 10, 2020, whether to proceed with the trip, in the event that circumstances arise, or persist, in connection with COVID-19 (coronavirus pandemic).

### Payment Schedule:

- 1<sup>st</sup>: \$500 due at sign-up.
- 2<sup>nd</sup>: If Air Option is chosen, \$250 due September 17, 2020.
- 3<sup>rd</sup>: Trip and Air Balance due October 15, 2020.

**W-SSOC Cancellation Policy:** Refer to the W-SSOC Crested Butte'21 Trip Application for full details.

- All monies refunded to participants of record in the event of trip cancellation if resulting from government- or resort- or our airline-mandated cancellation due to COVID-19. You are responsible for your own cancellation fees, if any, for any arrangements (e.g., air) that you make on your own.
- No fee for individual cancellation received on or before October 15, 2020.
- No fee for dropping your air and changing to Land Only provided 1) **Participant inquires in advance and receives reply from** Trip Administrator; 2) we have not dropped unneeded air and 3) we have not submitted passenger names to the airlines (i.e., issued the air e-tickets). Usually, this is done about 95 days prior to departure (in this case, before November 17, 2020).
- \$50 fee + unrecoverable moneys (not to exceed trip cost) for cancellation after October 15, 2020. Unrecoverable moneys increase as commitments are made for you.
- If your space is filled after October 15, 2020, fee is \$50 + air ticket rewrite fee (if applicable) + any direct expenses associated with filling your space (e.g., phone, FedEx, airline name-change fee).
