

**Trip Description: W-SSOC Ski Vacation
Salt Lake City, UT
Saturday to Saturday, January 16-23, 2021**

Eligibility: Open to Members in Good Standing of W-SSOC. Membership must be current from time of sign-up through end of Trip. Member of an Authorized Club of Crescent Ski Council must join W-SSOC.

Requirements to be Placed on, and Stay on, the Trip: 1) Eligibility met; 2) Trip Application current; 3) Payments current; 4) Space available (air, if applicable, and, or, lodging) and 5) Compatible roommate(s) available. See Trip Application for additional info.

Trip Inclusions: Basic Package includes ground transfers between SLC airport and hotel (regardless of your flight arrival/departure times), seven nights lodging in double-occupancy hotel room with two Q beds, microwave, TV and mini fridge, use of indoor pool, hot tub and sauna at the Crystal Inn-Murray, Salt Lake City, UT, breakfast daily + group pizza party (Sorry, dinners no longer available; other mitigation procedures for COVID-19 might also be required); W-SSOC Administration and parties.

Trip Exclusions: Air (but ground transfers, SLC airport-Crystal Inn-SLC airport are included) and lift tickets/bus passes (See Options D, below, for Super Pass or Option E for IKON Pass.

(3) Super Pass is good for the number of days purchased within a 14-day window at any mix of Alta, Brighton (incl. night skiing when available), Snowbird including Tram, and Solitude (must be one day at a time at Alta and Snowbird; can be used at Solitude and Brighton on the same day), starting on the first day of use, and is good on Utah Transit Authority public buses and TRAX light rail.				
(4) UTA Bus #953 direct to Alta or Snowbird stops in front of Crystal Inn. For Solitude and Brighton, also catch UTA #953, but change to #972 at Smith's grocery or 6200 S Wasatch Blvd Park 'n' Ride, and reverse upon return.				
(5) Please inquire re: \$50 rebate with purchase of IKON pass through our agent. IKON includes skiing at all four resorts and technically does not include the UTA buses; however, sometimes drivers have allowed IKON holders to board. Otherwise, plan to pay-as-you go, or pre-purchase a UTA bus pass.				

Guarantee of Trip Prices and Inclusions:

Except for reasons beyond W-SSOC or Agent's control, Basic Package Trip Price is guaranteed for minimum 6, up to 20, participants. Sum of Basic Package + Single Occupancy participants = maximum 20 participants. A decision will be made before November 15, 2020 whether to offer the trip.

Payment Schedule. Payment required by cash, check or money order. We do not accept charge cards.

--Balance, including any options or other price adjustments, due October 15, 2020.

W-SSOC Cancellation Policy:

1. All monies refunded to participants of record (i.e., still "on" the trip) if we cancel the Trip before Nov. 15, 2020 or, any time, in the event of trip cancellation if resulting from government- or resort-mandated orders due to COVID-19. Individuals are subject to their respective airline policies for cancellation due to COVID-19.
2. No fee for cancellation received on or before September 17, 2020.
3. \$25 fee for cancellation September 18 through October 15, 2020.
4. \$50 fee + unrecoverable moneys for cancellation after October 15, 2020. Unrecoverable moneys increase as commitments are made for you.
5. If your space is filled after October 15, 2020, fee is \$25 + any direct expenses associated with filling your space (if applicable, e.g., phone, FedEx).
