

Trip Description: W-SSOC Ski Vacation Deer Valley, UT Saturday to Saturday, January 11-18, 2020

Eligibility: Open to Members in Good Standing of W-SSOC. Membership must be current from time of sign-up through end of Trip. Member of an Authorized Club of Crescent Ski Council must join W-SSOC.

Requirements to be Placed on, and Stay on, the Trip: 1) Eligibility met; 2) Trip Application current; 3) Payments current; 4) Space (air and, or, lodging) available and 5) Compatible roommate(s) available. See Trip Application for additional info.

Trip Inclusions: Basic Package includes ground transfers between SLC airport and hotel (must meet group flight arrival/departure times), seven nights lodging in double-occupancy hotel room at the Zermatt Resort & Spa, Midway, UT with K or two Q beds, microwave, TV, mini-fridge, use of indoor/outdoor pools and hot tubs, 5-day lift ticket (Deer Valley), free shuttles to ski areas, W-SSOC Administration and parties.

(1) Included ground transfers depend on group travel. If your arrival/departure times cannot meet the group arrangement, ground transfer will be refunded only if minimum is still met for the group (or if the group arrangement is canceled). Driving distance between SLC airport and Zermatt Resort & Spa is estimated at 51 miles. (2) 5-day lift ticket is included to facilitate comparison with other W-SSOC Ski Vacations. See OPTION D for various lift options. (3) For holders of the IKON ski pass, 5 days of skiing are included at Deer Valley but not Park City. If you have an IKON Pass, you should choose Option #D3. (4) Tips extra. Participants should plan to tip the Zermatt Resort shuttle drivers and hotel housekeepers.

Guarantee of Trip Prices and Inclusions:

Except for reasons beyond W-SSOC or Agent's control, Basic Package Trip Price is guaranteed for 10 rooms. Sum of Basic Package + Single Occupancy participants = maximum 20 participants. If we are able to expand the trip beyond 20 hotel rooms, and the expansion is made on or before August 15, 2019, cost will be market price; if after August 15, 2019, W-SSOC may add \$2/day up to maximum \$150 to the Basic Package Price for participants so added.

Payment Schedule. Payment required by cash, check or money order. We do not accept charge cards.

--1st \$300 due at sign-up.

--2nd IF OPTION A IS CHOSEN, \$416 due July 18, 2019.

--3rd \$400 due August 15, 2019; Additional payments may be made at any time in any amount.

--Balance, including any options or other price adjustments, due September 19, 2019.

W-SSOC Cancellation Policy:

- No fee for cancellation received on or before August 15, 2019.
- IF YOU CHOSE OPTION A: No fee for dropping your air and changing to Land Only provided 1) **Participant inquires in advance and receives reply from Trip Administrator**; 2) we have not dropped unneeded air and 3) we have not submitted passenger names to the airlines (i.e., issued the air e-tickets). Usually, this is done about 95 days prior to departure. Otherwise, paragraph 4. applies.
- \$25 fee for cancellation August 16 through September 19, 2019.
- \$50 fee + unrecoverable moneys for cancellation after September 19, 2019. Unrecoverable moneys increase as commitments are made for you and may include any airline-related price increases.
- If your space is filled after September 19, 2019, fee is \$25 + air ticket rewrite fee (if applicable) + any direct expenses associated with filling your space (if applicable, e.g., phone, FedEx).
