**Crescent Ski Council Racing Fees and W-SSOC Racing Fees**

\$40 / Racer Crescent Annual Racing Fee; W-SSOC pays to Crescent Racing for each Qualified Racer\*.

(\$5) W-SSOC Racing pays \$5 of the Crescent Fee

**\$35 Balance, W-SSOC Returning Racer Annual Fee** payable to “W-SSOC Racing Team.”

\$10 W-SSOC New Racer One-time Fee, payable by first person in the Racer Household

**\$45 Balance, W-SSOC New Racer Annual Fee**, payable by first person in the Racer Household

**\$35 W-SSOC New Racer Annual Fee, each additional Racer after the First New Racer in the Household.**

\*W-SSOC Racing pays \$40/Registered Racer to Crescent Racing for each Qualified Racer who registers to race (in Flight 1-20) of a Crescent Series Race. The fee is not due until a Racer becomes Qualified (i.e., attains a qualifying Crescent Handicap) no matter how many tries, or becomes Qualified but does not race in a Crescent Series Race. A Racer who pays fees in advance but does not meet these conditions may receive \$35 refund upon request; otherwise, it will be rolled over to the next season.
